JUDICIAL FRAMEWORK

- Specialisation of judges (military with chambers, juvenile with no training, economic crimes and traffic crimes – centralised)
- The example of the traffic case judges (technical knowledge, working with experts)

Constitutional and criminal principles

- Legality principle (no retrospective measures, strict consideration of the rules of term of limitation – env.: longstanding status and consequences, floating border)
- Officiality principle (hardly can find exemptions, only in case of low level of actual danger)
- Plea bargaining (only in practice, although env. matters would require it), renovation or restoration can lead to reducing the punishment without limitation

Precedent cases of the Supreme Court

• BH 2001.512

Horse tramping of illir trees – irreversible effects on a highly protected land. No fence, no supervision of 12 straying horses. Manure, grazing. 17 ha, 1200 trees. 300 days equivalent fine (500 HUF – 2 Euro) and the damages. Interests and procedural fee.

Precedent cases of the Supreme Court, 2

BH 2001.264

Purchasing a land, undertaking the clean up in the contract with the liquidator, than failing to do that. Dozens of barrels of mixed unknown materials and contaminated soil (estimated price was 5500 Euro). 10 months imprisonment, suspended for 1 year and 200.000 HUF (800 Euro) secondary fine

Green commando

- Started in 2004 joint survey and on site measures of the environmental, municipal, police and other authorities.
- With special targets (2004: dangerous facilities, 2005-6: transport of dangerous chemicals and dismantle of used cars, 2007: illegal waste shipment, 2008: illegal collection of coloured metals)

Green commando cont.

- 625 surveys in half a year, 232 only the inspectorate, 75 the municipality clerck, 357 police, border guard or tax authority, 42 NGOs
- Measures: 309 inspectorates (call for action, fine), 6 – clerck, 16 criminal cases, 12 measures from other authorities
